BIOGRAPHY:

Dr Lukas is an Omaha native and graduate of UNMC in 1998. She did her family medicine residency at Lehigh Valley Health Network, and completed the prestigious Robert Wood Johnson Clinical Scholars Program at the University of Michigan. She returned to Pennsylvania to open one of the first patient-centered medical homes in the state, it was a resounding clinical success but crashed under the weight of an oversold EMR! She became the director of Palliative Medicine and developed an innovative home-based palliative medicine program that supported primary care practitioners attempt to manage their frailest patients. It demonstrated net hospital savings of 25% of predicted costs. This program received the Circle of Life award for innovative practice. She spent 5 years as the Chief Medical Officer for Hospice of the Chesapeake where she oversaw the care of 500 hospice patients per day, and developed programs in palliative medicine at two community hospitals. Since returning to Omaha she has been the medical director of palliative medicine at Nebraska Methodist Health System and led the consortium that developed the Nebraska Emergency Treatment Orders form.
